What are the new Federal Poverty Income Guidelines (FPIGs) for 2014 and when were they effective?

The 2014 FPIGs were published in the Federal Register and are effective January 22, 2014. Handbook pages will be issued shortly. The percentages are applied accordingly. (FR Doc. 2014-01303)

- MAGI – 33%, 133%, 157%, 215%.
- Healthy Beginnings – 100%, 133% and 185%
- Healthy Horizons (to include SLMB and QIs) – 100%, 120% and 135%
- Qualified Disabled Working Individual – 200%
- Family Works – 235%
- Medical Assistance for Workers with Disabilities (MAWD) – 250%
- SelectPlan for Women – 214%

Note: Healthy Beginnings budgets will be converted to a MAGI category when the budgets are reviewed at semi-annual reporting, renewal or case change. Eligibility for SelectPlan is determined using MAGI-based determination and the MAGI-converted income limit of 214% FPL.
