DISBURSEMENT AND CORRESPONDING DATES FOR CASH/SNAP BENEFITS

KEY

- Deadline** The last day action can be taken on a case in this cycle to become effective with the disbursement date for this disbursement day number. Online transactions are available until 6:00 PM.
- Benefit Hold** The deadline for placing a hold on a cash check via US Mail. The benefit hold deadline for all benefits issued through EBT is close of business on the day prior to disbursement.
- Mailing** The date centrally issued, recurring cash benefits are placed in the US Mail.
- Disbursement** The date check benefit is available; or SNAP benefit becomes available through EBT.
- Supp** Indicates non-payment dates for system processing purposes when there are more than 20 work days in a month. Supplemental payment dates designated after payday 10 are assigned payment day numbers above 20 even if they occur earlier in the month than payday 20, and have no affect on recurring benefits.

Example: There are 23 work days in March 2011. The first payment cycle, 1/11, occurs on March 2, and continues for 10 working days until March 15. March 16 is a non-payment date and is assigned SUPP 21. The second payment date for cycle 1/11 is the next work day, March 17, and concludes with payment cycle 10/20 on March 30. March 31 is a non-payment work day and assigned SUPP 22.

Key:

- Benefit Period** This is the period covered by the SSI/SSP benefit.
- SSA File** The date the final 8036 file will be received from Social Security Administration.
- DPW Deadline** The date DPW will process the SSA file against CIS and create the monthly recurring issuance file.
- BUCD Receipt** The date DPW will transmit issuance files to Treasury BUCD.
- Benefit Hold** The deadline for CAO to place a hold on a check issued via US mail. The benefit hold deadline is two business days prior to the mailing date. BUCD will receive the benefit hold file the next business day.
- Mailing** The date the recurring benefits paid by check are placed in the US mail.
- EFT Date** The date the EFT is sent by BUCD to the client's financial institution.
- Disbursement** The date the SSI benefit must be in the recipient's hands. For EFT issuances, this is the date the client must have access to their funds in their financial institution. This is the date of the check.
