SUBJECT: Updates to the PA 600 B – Pennsylvania's Breast and Cervical Cancer Prevention and Treatment Program (BCCPT) Application

PURPOSE

To introduce the International Classification of Diseases-tenth revision (ICD-10) code changes and other revisions to the PA 600 B which are effective October 1, 2015.

BACKGROUND/DISCUSSION:

On August 4, 2014, the U.S. Department of Health and Human Services (HHS) issued a rule finalizing October 1, 2015 as the new compliance date for health care providers, health plans, and health care clearinghouses to transition to ICD-10. Claims for all healthcare services with dates of service on or after October 1, 2015, and all hospital inpatient claims with discharge dates on or after October 1, 2015, must use the ICD-10 code sets. Providers are required to use ICD-9 code sets if the date of service occurred through September 30, 2015.

As a result of the ICD-10 Final Rule, the PA 600 B's breast and cervical cancer diagnoses codes have been updated with the new ICD-10 code sets. These codes correspond with the BCCPT disability/incapacity codes in eCIS (Disability screen) and CIS (CQDISB). Additionally, the PA 600 B has been updated to no longer include a Part A for the HealthyWoman Program (HWP). The Part A and Part B (BCCPT application) are now independent of one another and are standalone forms. The Department of Health (DOH) has a separate form to gather Part A's information titled the *HealthyWoman Program (HWP) Consent and Enrollment Information* form. The PA 600 B will continue to serve as the Department of Human Services' (DHS) BCCPT application.

Below is a table detailing the ICD-9 code sets and how they translate to the ICD-10 code sets, effective October 1, 2015. Until changes are made to eCIS/CIS to update to ICD-10, please continue to enter the ICD-9 codes in eCIS as they correspond to the ICD-10 codes on the PA 600 B.
