<sup>\*</sup> SSI (A, J, M) beneficiaries are eligible for Buy-In of Medicare premiums as QMBs and are enrolled by SSA. SSA enrolls J categories in Buy-In after the beneficiary has received Social Security disability benefits for 24 months. If the SSA category is not enrolled in Buy-In after three months of Medicare entitlement, then stage a manual accrete in the Buy-In system.

Space prohibits display of 2 persons limit for all categories.

<sup>\*\*</sup> For a MAWD applicant/recipient living with a spouse, use the 2 person limit. However, if the spouse is receiving HCBS services, use the 1 person limit for the MAWD applicant/recipient with Buy-In.
