On February 1, 2013, the Department of Public Welfare (Department) streamlined and modernized the human services licensing process such that licenses to operate are issued to currently-licensed providers upon receipt of their annual renewal application for licensure.

The Department has received your December 23, 2013 renewal application to operate the above Assisted Living Home pursuant to 55 Pa.Code § Ch 2800. A regular license is being issued in response to your application. Your license is enclosed.

Please be advised that, pursuant to 55 Pa.Code § 20.31 relating to annual inspection, the Department is required to conduct an onsite inspection of the above Assisted Living Home at least once every twelve months. The Department will conduct an inspection of The Hill at Whitemarsh Oakley Hall Assisted Living within the next twelve months. If evidence of noncompliance with 55 Pa.Code § Ch 2800 relating to Assisted Living Homes is found during the inspection, the Department will take appropriate enforcement action.
