The Department of Human Services (Department) issued you a Third Provisional Certificate of Compliance to operate the child residential facility known as Shuman Center, 7150 Highland Drive, Pittsburgh, Pennsylvania 15206 (License # 414313), which was effective from March 30, 2017, to September 30, 2017.

During the period of provisional licensure, Department staff made announced and unannounced visits to the facility to evaluate implementation of the approved plan of correction and to provide technical assistance. As a result of the Department's annual approval inspection of the above-named facility on September 6-8, 2017, our program representative verified full compliance with the regulations in 55 Pa. Code Chapter 3800 as noted on the enclosed Licensing/Approval/Registration Inspection Summary.

Therefore, a regular Certificate of Compliance effective September 8, 2017-September 8, 2018 is hereby issued (License # 414313). You are required to notify the Department prior to any change in the operation of your facility as specified at 55 Pa. Code §20.58. Also, 55 Pa. The Department of Human Services, Office of Children, Youth and Families, Western Region (Department) conducted an Annual Licensing Inspection of Shuman Juvenile Detention Center on 09/06/2017 through 09/08/2017 for the inspection period beginning 03/30/2017 and ending 09/30/2017. Shuman Center's current license is a provisional license due to incidents that have occurred during restraints of residents. During this timeframe, Shuman Center had 717 admissions (many of which were re-entries). For the inspection, the Department randomly selected a twenty percent sample of those admissions. As a result, 143 resident files were reviewed and 33 of 72 personnel records, 16 of which were files of all new staff hired since 03/30/2017. A physical site inspection was completed and there were no regulatory concerns noted. The Licensing Inspection Summary (LIS) from last year's inspection was reviewed and the citations identified on the report no longer exist. Nine residents (one from each active unit) and twelve staff were interviewed. Residents interviewed as part of the inspection did not report any concerns with restraints and believe they were being done appropriately. Staff members interviewed noted an increased attention to do everything possible to de-escalate a situation before having to use physical intervention. No issues or concerns were reported during these interviews. No regulatory violations were noted during the inspection.
