Plan of Correction

ON 11/16/17 during an inspection by the Department of Human Services Licensing discovered that the ASP for resident number 1 was not signed by the creator. This is a violation to regulation 2800.227. This regulation is important to ensure accountability for the plan by all parties.

The creator was informed educated and it was immediately signed. This was an oversight on the creator's part and as the Director of Nursing will pay special attention that signatures of all participants are obtained upon completion.
