The following corrective action will be completed in accordance violation associated with **Regulation 2800.95 – Furniture and Equipment**

Currently, *The Hill at Whitemarsh -Oakley Hall Assisted Living* has several residents using an enabler bar on their bed. *The Hill at Whitemarsh* has ordered new Enabler Bars which should be arriving approx. 10/31/2019. These new bars will have a protective cover so that the resident will not be able to get a limb caught between the bed and the bar. Upon arrival, the bars will be installed on the resident's bed. Occupational Therapy will assist with the installation to make sure they are secured firmly in the best spot for the resident's need.

In the future, when a resident has been assessed by Therapy and has recommended that a bed enabler is needed, these specific bars will be ordered and installed for the resident. All Enabler Bars will be added to each resident's support plan as they are placed on beds. The installation will be completed by November 6, 2019.
