42.c. A resident shall be treated with dignity and respect.

Description of Violation

Multiple staff members and residents indicate direct care staff person A, hired 1/9/19, treats residents in an impatient and disrespectful manner, and is "rude" and "nasty" towards residents. On 12/2/19, staff person B received 2 complaints regarding direct care staff person A's tone and mannerism toward residents, and staff person A received a verbal warning from the home on 12/4/19. On 1/25/20 at approximately 9:30 am, resident #1 fell in the bathroom near the dining room. Ancillary staff person C was present at the time of the incident and indicates direct care staff person A yelled at resident #1, as he reached up for assistance in standing, "Don't touch us! You're gonna hurt us!" When the resident was standing, direct care staff person A then yelled at the resident, "Go sit down somewhere. I'm not picking you up again."
