

On 2/15/22, resident #1's bedside enabler was not covered, which had openings measuring 9.5" x 11.5", which pose an entrapment hazard.

On 2/15/22, resident #2's bedside enabler was not covered, which had openings measuring 9.5" \times 11.5", which pose an entrapment hazard.

Plan of Correction Accept

A cover has been placed over the bedside enabler for Resident #1 and Resident #2 to reduce the risk of entrapment. There are no other enabler bars being utilized in the facility.

The nursing and housekeeping staff will be educated on the requirements of 2800.18.b as it relates to this specific violation. All other resident bedside lamps have been inspected for proper positioning to allow the lamp to be turned on/off from bedside.
