Inspection Narrative

Pennsylvania's Department of Human Services, Office of Children, Youth and Families (Central Region) conducted an Annual Licensing Inspection of Children's Aid Home Program of Somerset County (Residential) on March 22 and 23, 2023 for the licensing year extending from July 15, 2022 to July 15, 2023. During the inspection, Departmental personnel reviewed:

- 05 of 05 personnel records.
- 02 of 09 child records.

As part of the licensing process, Departmental personnel also reviewed regulatory documents, including fire drills, to measure compliance. Departmental personnel also completed physical site inspection and interviewed 02 staff members and 02 children.

Based on regulations with regard to Chapter 3800 (Day Treatment), the Department of Human Services, Office of Children, Youth and Families found no areas of regulatory noncompliance.
