103.f. Food requiring refrigeration shall be stored at or below 40°F. Frozen food shall be kept at or below 0°F. Thermometers are required in refrigerators and freezers.

#### **Description of Violation**

The Connection's activity kitchen located in the resident's activity area did not have a thermometer in the Frigidaire brand refrigerator at the time of inspection.

On the same day violation was noted our Director of Maintenace installed a thermometer in the refrigerator and secured it with a zip tie so it cannot be removed. Daily checks were implemented with sign off sheet to ensure functionality and placement.

# 105g Dryer lint removal

## 3. Requirements

2800.

105.g. To reduce the risks of fire hazards, lint shall be removed from the lint trap and drum of clothes dryers after each use. Lint shall be cleaned from the vent duct and internal and external ductwork of clothes dryers according to the manufacturer's instructions.

#### **Description of Violation**

The first-floor resident laundry room, there was an accumulation of lint in the two dryers located in the laundry room.
