On February 1, 2013, the Department of Public Welfare (Department) streamlined and modernized the human services licensing process such that licenses to operate are issued to currently-licensed providers upon receipt of their annual renewal application for licensure.

The Department has received your March 18, 2013 renewal application to operate the above County Children and Youth Agency pursuant to Title 55, PA Code, Chapter 3130. A regular license is being issued in response to your application. Your license is enclosed.

Please be advised that, pursuant to 55 Pa.Code § 20.31 (relating to annual inspection), the Department is required to conduct an onsite inspection of the above County Children and Youth Agency at least once every twelve months. The Department will conduct an inspection of Erie County Children & Youth Services within the next twelve months. If evidence of noncompliance with Title 55, PA Code, Chapter 3130. is found during the inspection, the Department will take appropriate enforcement action.
