\* SSI recipients with Medicare are enrolled in Buy-In by SSA. If SSA has not enrolled the recipient in Buy-In after three months of Medicare entitlement, process a manual accrete in the Buy-In system using the first month that Medicare began.

\*\* When a MAWD applicant/recipient is living with a spouse, use the 2-person limit. However, if the spouse is receiving HCBS, use the 1-person limit.

NMP and MNO spend-down recipients are eligible for Buy-In, provided that monthly income is within QMB or SLMB eligibility limits prior to any spend-down. Authorize the MA category with PSC 21 or 22 and process a manual accrete.

Space only allows display of 1 and 2-person limits. SSI, Special SSI and LTC categories use 1-person limit only.
