

GET YOUR STATE TAXES BACK

If you pay state income taxes ... Pennsylvania may owe you tax money back!

You can get all of your state tax back if your 2021 income is not over:

Single person \$	6,500
Couple\$1	3,000
Single parent with one child\$1	6,000
Couple with one child\$2	2,500
For each additional child, add\$	9,500

You can get part of your state tax back if your 2021 income is between:

Single person	\$6,500 -	\$8,750
Couple	. \$13,000 -	\$15,250
Single parent with one child	. \$16,000 -	\$18,250
Couple with one child	. \$22,500 -	\$24,750
