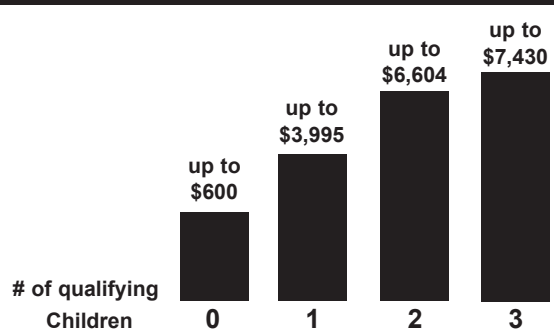

GET YOUR FEDERAL TAXES BACK

Who May Qualify for Earned Income Tax Credit (EITC)?



Earnings less than:				
SINGLE	\$17,640	\$46,560	\$52,918	\$56,838
MARRIED	\$24,210	\$53,120	\$59,478	\$63,398

You must file a return to claim this credit!
Investment income must be \$11,000 or less for the year.
Missed out? You can file up to three years back!

For workers raising children under age 13, the Child and Dependent Care Credit can be claimed in addition to the EITC. However, a child can qualify for the EITC if they are permanently disabled, under age 19, or under age 24 and a full-time student.

You must file a tax return to receive these credits!

You can file tax returns up to three years back and receive these credits even if you were working part-time.

Keep All of Your Refund! Get Free Help Filing Your Income Taxes!

The Internal Revenue Service (IRS) Volunteer Income Tax Assistance (VITA) will help you fill out your tax forms for free. VITA sites are open through April 15. GET YOUR STATE TAXES BACK

If you pay state income taxes ... Pennsylvania may owe you tax money back!

You can get all of your state tax back if your 2023 income is not over:

Single person	\$6,500
Couple.....	\$13,000
Single parent with one child.....	\$16,000
Couple with one child.....	\$22,500
For each additional child, add.....	\$9,500

You can get part of your state tax back if your 2023 income is between:

Single person	\$6,500 - \$8,750
Couple.....	\$13,000 - \$15,250
Single parent with one child..	\$16,000 - \$18,250
Couple with one child.....	\$22,500 - \$24,750
