- Benefit Period** This is the period covered by the SSI/SSP benefit.
- SSA File** The date the final 8036 file will be received from Social Security Administration.
- DHS Deadline** The date DHS will process the SSA file against CIS and create the monthly recurring issuance file.
- BUCD Receipt** The date DHS will transmit issuance files to Treasury BUCD.
